CONSUMER PRODUCT SAFETY IMPROVEMENT ACT 2008 (CPSC)

Please make every effort to check in items on Tuesday, March 16. If you check in on Wednesday, March 17 we will do our best to make your items available for the Preview Sale but that may not be possible.

Due to the Consumer Product Safety Improvement Act 2008, we have some changes to our guidelines. The CPSC requires manufacturers to certify child products made after 2/10/2009 meet all of the new safety standards and the lead ban. "Children's products with more than 600 parts per million (ppm) total lead cannot lawfully be sold in the United States on or after 2/10/2009 even if they were manufactured before that date."

Consignment Sales and Thrift Stores are not required to test all products received for resale; however, as a consignment sale we are expected to not accept and sell any products on the CPSC recall or banned lead lists.

In the best interest of our children, we will NOT accept items that appear on the CPSC recall or banned list. As a consignor you must review this list and be sure you do not bring items on this list to consign. The recall and lead lists of unacceptable items are located at: www.cpsc.gov.

Some of the items we will not accept are:

- ❖ Any clothing with charms or jewelry attached (includes swimsuits, socks, shoes)
- ❖ Children's jewelry (including, but not limited to, metal and plastic dress-up jewelry)
- ❖ Any clothing items with drawstrings (including but not limited to hooded jackets, sweatshirts, swimsuit cover-ups)
- ❖ Painted cribs
- ❖ Stork Craft Cribs
- ❖ Simplicity Brand Drop-Side Cribs
- ❖ Jardine Cribs sold by Babies 'R Us
- ❖ Fisher-Price Simplicity Rainforest Portable Play-Yard
- ❖ Playkids Convertible Cribs
- ❖ Evenflo Majestic High Chairs
- ❖ Doll clothing and accessories with charms and jewelry attached
- ❖ Doll Jewelry

Many toys are recalled due to the lead hazard. Please take a moment to check your items against the CPSC list located on their Website.

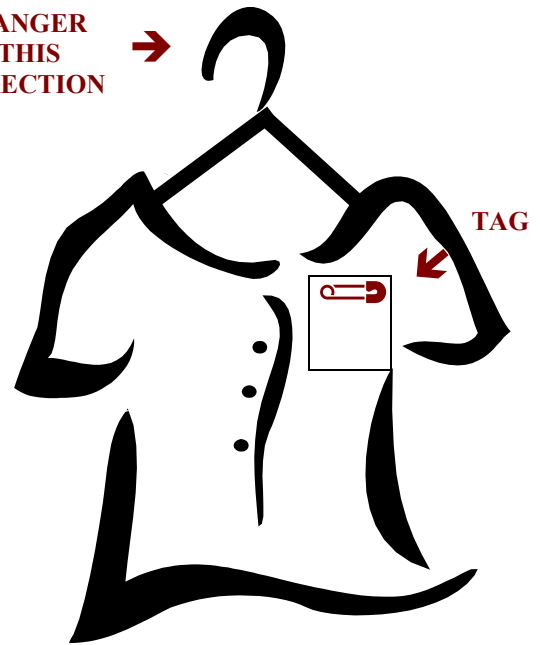

GETTING YOUR ITEMS READY TO SELL

- ❖ Print tags for sale using your specified color cardstock paper (you will be given a certain color depending on your seller code.) We will be happy to print your tags for you. You may pick up the cardstock or printed tags at the church. Tag template is on the last page.
- ❖ Using blue or black ink, complete all sections of the item's tag including the description. In the event the tag is separated from the item, a description will be very helpful.
- ❖ Please complete the Registration Form (Page 7). The Inventory of Items (Page 8) is optional. It is helpful to us should a tag become separated. If you choose to inventory your items, please keep a copy.
- ❖ Pricing should be in 50¢ increments. If you **DO NOT** wish for an item to be sold at half price, then circle the NR on the tag. **ALL TAGS NOT CIRCLED WILL BE SOLD FOR HALF PRICE ON SATURDAY.**
- ❖ All clothing is to be tagged on the left shoulder of the garment for tops (see Exhibit B), and the left waist band for bottoms. **PLEASE USE WIRE HANGERS ONLY!**
- ❖ Toys-please package small pieces, directions, and puzzle pieces in a clear storage baggie. Tape the baggie closed with clear packing tape and tape the baggie to the toy (if needed.)
- ❖ Please use only masking tape on books, puzzles and videos. Any other tape will tear the items.
- ❖ Please sort clothing by gender and in size order ahead of time, prior to check-in.
- ❖ We reserve the right to refuse any items — even after check-in.

- ❖ When you check-in, please indicate if you will pick up or donate your unsold items.
- ❖ Pick up is Saturday, September 25 from 5:00PM-6:00PM in the Family Life Center.
- ❖ All items remaining after 2:00PM will become property of Norcross First United Methodist Church and will be donated to a good charity. **THERE WILL BE NO EXCEPTIONS!**
